Harmonic is committed to reducing the environmental impact of its business and participating in reducing the environmental impact of its value chain. We endeavour to:

Policy Aims

- Meet or exceed all relevant regulatory requirements;
- Reduce our environmental impact and continuously improve our sustainability performance;
- Reduce the Scope 1, 2 and 3 greenhouse gas (GHG) emissions of our business;
- Incorporate environmental factors into business decisions;
- Increase employee awareness and training;

Products and Services

- Invest in innovations to reduce the environmental impact throughout the lifecycle of our products and solutions, including reduced power consumption of our products;
- Minimize service-, support- and maintenance-related travel through real-time monitoring
 of our customers' network elements and our remote diagnostic and repair capabilities;
- Use general purpose (reuseable) compute platforms to host on-premise solutions;
- Lead the video workflow industry to the greater energy efficiency and flexibility of ondemand SaaS-based solutions;
- Coordinate with our customers to manage the end-of-life of our products;
- Incorporate environmental considerations in the development of our products and services.

Energy Consumption and Facilities

- Utilize renewable energy sources for our facilities whenever practicable;
- Continually seek to increase energy efficiency and reduce the amount of energy we use in our facilities and operations;
- Reduce our office space needs wherever practicable;
- Improve heating and cooling temperature management at our facilities to reduce our energy consumption;
- Consider energy consumption and efficiency when purchasing new equipment.

Procurement

- Include environmental and other applicable sustainable procurement criteria when purchasing equipment, supplies and services;
- Favor products and services with low or the lowest environmental impact;
- Use local labor and materials whenever practicable.

Resources and waste

- Minimize use of paper in our offices and raise awareness of waste sorting at our facilities;
- Reduce product packaging;



- Seek to buy recycled and recyclable products and supplies;
- Reuse or recycle, including electronics;
- Utilize only licensed firms for waste disposal and recycling;
- Reduce the use of water at our facilities;
- Support the use of sustainable water sources, availability of safe drinking water, and protection of both ecosystems and communities through proper sanitation we believe the right to water is a basic human right;

Transportation

- Minimize air freight shipment of products;
- Significantly reduce unnecessary business travel through video conferencing, virtual product demonstrations and on-line product and technical training;
- Reduce employee commuting through work-from-home initiatives;
- Encourage and accommodate the use of public transportation, bicycles and carpooling;
- Support electric vehicles through Company charging stations and other initiatives;

Culture

- Involve all Harmonic employees in the implementation of this Policy, to maximize its impact;
- Provide employees with environmental impact and awareness training and related activities;
- Update this Policy regularly in consultation with employees and other stakeholders;
