

Subject: Validity period for grant of registration under Compulsory Registration Scheme

The Competent Authority of BIS has decided that :

1. The registration under CRS shall be granted for 2 years with immediate effect.
2. The validity of registration granted earlier for one year shall now stand amended to two years instead of one year mentioned in the letter for grant of registration. For example registration granted on 24 March 2014 for one year & mentioned as valid upto 23 March 2015 in the letter for grant of registration issued by BIS shall now be valid upto 23 March 2016.
